Item 3 NATIONAL PARK SERVICE REPORT

Carolyn Shoulders gave a brief update on the various aspects of the Park Service projects. There was a discussion on the status of the Pacific Way bridge. Carolyn also answered questions about the status of the remodeling of the parking lot.

Item 4 FIRE DEPARTMENT REPORT

Fire Chief John Sward reported. Negotiations for a new firehouse are progressing. The Fire Department hopes that construction can begin in the spring. The MBVFA has been awarded a \$44,000 grant from Fireman's Fund Insurance for the purchase of a new squad truck. They have received permission to use West Marin Funds for the matching portion.

MBCSD Minutes October 13, 2010 Although a grant for tree removal was awarded some time ago, the requirements to be met prior to beginning the work are extensive, so work has not yet begun.

Leighton related that no funds can be spent from the fire tax monies until the MBVFA provides the Board with a budget for expenditures to be approved by the Board.

Item 5 PUBLIC HEARING ITEMS

Collection of Parcel Tax Via Water Bill Rather Than Property Tax Bill -

The proposal to collect the \$300 parcel tax for water capital improvements via the water billing process, versus having the County collect it when it collects property taxes, was broached at the last meeting. One question that arose at the last meeting was whether this tax can be claimed as a deduction on income tax returns. The Board's research has shown that it is not deductible regardless of the method of collection.

Water Rate Increase (Last One Five Years Ago) –

An 8.5% increase in water rates was broached at the last meeting.

Introduction and Reading of Ordinance (by title only) -

District Manager Hills read the Ordinance by title only, as follows:

"Ordinance No. 2010-2 - An Ordinance of the Board of Directors of the Muir Beach Community Services District establishing a schedule of rate charges for water service and capital improvements."
