Subject: Ad Hoc Personnel Committee Recommendation

To The CSD Board

Subject: Bill's Hours To Date And A Short-term Plan To Manage Them From Now To June 30th.

What We Found:

- · Bill's time required to attend to MBCSD matters has greatly exceeded the 20 hours per week agreement.
- Further, the committee examined Bill's hours to date and-found that he has certainly worked them. (Attached is a listing of Bill's hours and the tasks to which they were allocated since January 12th.)
- The committee also found that the absence of a job description and CSD priorities set by the Board -- as well as clear accountability and reporting lines --makes it difficult to do anything more than accept the hours. The committee is recommending temporary actions that will compensate the District Manager (DM) for the extra time needed to meet the community's needs in the near future while monitoring the nature and extent of the DM's activities; from this we can learn what is really involved and how it can be effectively structured to get the best results and control costs.
- The bottom line is that it is the board's responsibility to set and oversee the job responsibilities and priorities of the DM and to direct the work in a manner that is fiscally responsible to Muir Beach residents/taxpayers. That is where we, and we hope the Board, will focus.
- While our immediate task as a committee is to deal with the pressing matter of Bill's hours, we want to do it in a way that helps us in our primary assignment of creating an appropriate personnel system for your review.

Committee Recommendations

- · In the short term, have the District Manager focus on these priorities:
 - o Fix and ensure our drinking water system,
 - o Legal and financial reporting requirements, etc., continuing to function on a day to day basis and complete the delinquent reports ASAP.
 - o Deal with and report back about those Sunset Way issues that must be dealt with urgently.
 - o Assist Gary in preparing the Board agenda, sending out CSD meeting notices, etc.
 - o With Gary's approval, Bill should spend time on any emergency that arises
- · Set mechanisms and protocols in place to enable the board to oversee the DM's hours —so the board can effectively address the short and longer-term, strategic issues. To do that, the committee suggests that the MBCSD Directors consider this at the regular board meeting scheduled for May 4th and briefly discuss and, hopefully, agree to adopt our recommendations which are:
 - o Compensate the District Manager for a total of 153.25 hours beyond the 20 hours/week for his salaried position -- from January $\mathbf{1}^{st}$ to April $\mathbf{7}^{th}$. As part of this, 30 hours will be taken as compensatory time. 123.25 hours @ \$53/hour = \$6532.25 total monetary impact.)
 - o From April 8 to June 30 pay the DM to work as a 20 hour/week salaried employee, with up to an additional 20 hours per week compensated at \$53/hour. Further, give the DM flexibility to work an average of 40 hours/week over the stated period.

- § During this period, the District Manager will provide weekly an account of how his hours are spent from April 8 to June 30 and will make recommendations to the board as to any parts of the current job description that might be structured or delegated differently.
- o Moving forward, the DM will also provide to the ad hoc committee a weekly work plan of anticipated tasks and projected associated hours. It will enable us to analyze anticipated vs. actual work/hours.
- o The DM will also propose those activities listed in his job description that cannot be accomplished and should be eliminated or those activities that should be done with additional or outside assistance.
